Finance Report:

President & CEO Tommy Stringfellow provided the following report:

- Stringfellow reviewed the October financial statements:
 - October attendance is down 5.2% from budgeted but up 13.6% over the previous year.
 - o Earned revenue 8.1% over budgeted, 16.2% over previous year.
 - o Government support Richland County ahead of projections.
 - Expenditures timing issues w/invoices being paid. Anticipate an increase in the coming months.
 - o General admission visits increasing, 12.2% ahead of 2022.
 - o Dynamic pricing with the new software system is going well.
 - o SSA (concessions and facility rental) is very strong. Up over budgeted and previous year.
 - o Miscellaneous revenue is up due to Ashley Harris investing in high yield savings.
 - o Reeves motioned to approve the financials, Williams seconded, m/c unanimous.

President & CEO Report:

President & CEO Tommy Stringfellow provided the following report:

- The second reading of Richland County bond is tentatively set for December 5th. We have a running list of speakers for the public hearing. Public hearing speakers should discuss different topics like education, conservation, and economic impact.
- Commissioner Reeves suggested thanking all Richland council members for voting "yes" across social media platforms.
- Commissioner Davidson suggested going on a podcast to discuss the bond.
- Call for a motion to spend up to 8 million dollars on the Gondola project <u>Davidson moved</u>, <u>Shockley seconded</u>, m/c unanimous.

Chief Administrative Officer Report:

Chief Administrative Officer Christie Vondrak provided the following report:

- Ashley and Hopper are doing well, baby Hopper is getting tall!
- Wild Lights VIP Party is tonight hope to see all commissioners there!
- Will send an email with more details for Richland County public hearing.
- Riverbanks has just qualified for Public Service Loan Forgiveness. Staff are very excited to take advantage of the new perk.
- Staff Saluda River Sweep was a success.
- The Horticulture team went to Mast General Store to spruce up the courtyard. Will refresh several times a year moving forward.

Chief Operating Officer Report:

Chief Operating Officer Lochlan Wooten provided the following report:

- Komodo dragon project is progressing.
- Interviewed two architects for Education construction project.
- Boo at the Zoo went wonderfully. Nearly 30,000 people attended. Revenue greatly outpaced projected, largely due to dynamic pricing.
- Wild Lights commercial presentation.
- October membership was the strongest month on record.
- Attendance behind budget by only 59 guests, but up from previous year.
- Returned from Tanzania. RBZ hosting trip in September 2024. Met with African People and Wildlife to investigate human animal conflict deterrents. (Living fences, bee walls etc.)
