#### Attendance

With an outstanding April, attendance has surpassed the one million mark and is 1,024,142 as of April 30, 2018. This is almost 53,000 over budget.

Riverbanks ended April with over 40,000 memberships and 2,539 ahead of budget. The increase from budget is predominately in Regular (Individual/Family) and Plus memberships.

#### Revenues

Net revenues increased over \$2.1m in April. Year-to-date revenues are \$13,483,690 and are 86.5% of annual budgeted revenues. The breakout between earned and governmental is noted below.
